The University considers subawards synonymous with the subgrants and subcontracts referred to in OMB Circular24 (relocated to 2 CFR, Part 220)

According to the University of Alaskaccountingand Administrative ManualSection 100, D-07 "Subrecipient Monitoring the University defines a subrecipient as a non-Federal entity that expends Federal awards received from-thomasingh entity to conduct a substantive portion of the program or activity for which the original dawas received for a federally funded program. In addition, subrecipients are required to meet compliance requirements, have their performance measured against meeting the objectives of the program, are responsible for programmatic decision making, and determining eligibility for assistance. OMB Circular A133 monitoring purposes, the university segregates other educational institutions, profit institutions, and state and local governmental subrecipients from other subrecipients in accounting the manufacture.

A contractual arrangement to acquire goods or services required for the conduct of a sponsored program from a vendor is not considered a subaward. Vendors include dealers, distributors, merchants, or other seller's of goods and servændor is distinguished from a subrecipient by the fact that a vendor provides these goods or services during the course of their normal business operations to many different customers. Additionally, vendors operate in a competitive environment, the goods and services provided are ancillary to the operation of the sponsored program, and the vendor does not have responsibility for adherence to program compliance requirements. Consultants are generally considered vendors because they are normally not rec
